AMENDMENT TO THE PY 2024 ACTION PLAN
DATE OF NOTICE: MAY 8, 2026

The City of Moorhead announces a proposed amendment to the Program Year (PY) 2024 Community Development Block Grant (CDBG) Action Plan. The amendment includes the cancellation of one previously approved activity and the addition of one new activity. A 30-day public comment period begins May 8, 2026, and will conclude June 7, 2026.

A public hearing regarding this amendment will be held on **May 26, 2026**, before the Moorhead City Council. Final City Council consideration of the proposed amendment is scheduled for **June 8, 2026**.

NOTICE OF CANCELLATION OF CDBG-FUNDED ACTIVITY

The following CDBG activity is proposed for cancellation:

Activity: Youth Program – Afro American Development Association (AADA)

Description: Youth program intended to support the development of talents and abilities through meaningful activities, education, career awareness, and work experience

CDBG Allocation: \$8,000

Location: 1132 28 Ave S, Moorhead, Minnesota

Reason for Cancellation: The activity was approved January 8, 2024 but was not implemented by AADA

NOTICE OF ADDITION OF NEW CDBG-FUNDED ACTIVITY

The following new activity is proposed for addition to the PY 2024 Action Plan:

Activity: Scholarship Funds for Low- to Moderate-Income Youth

Description: Provide funding to the Moorhead Parks and Recreation Scholarship Program to support access to recreational activities for low- to moderate-income youth

CDBG Allocation: \$8,000

National Objective: Low/Moderate Income Clientele (LMC)

Location/Service Area: Moorhead, Minnesota

ADDITIONAL NOTICE REGARDING THE PY 2026 DRAFT ACTION PLAN

The PY 2026 Draft Action Plan, currently available for public comment, includes a project previously titled Home Rehabilitation Loan Program. This project will instead be titled:

Rehabilitation.

This project may include the Home Rehabilitation Loan Program and/or the Rehabilitation of Affordable Rental Units activities.
